Item Title: Jewel Ventura Lift Station Project Change Order No. 2 Contract

VILLAGE BOARD ACTION

Adopt a Resolution authorizing the Mayor to execute Change Order No. 2 for the Jewel Ventura Lift Station Project between the Village of Roselle and DiMeo Brothers, Inc. for a contract time extension.

Executive Summary:

At the June 25, 2018 the Village Board approved Change Order No. 1 to the contract with DiMeo Brothers, Inc. to open cut the sewer installation in lieu of directional boring. As part of an approval, a change order was also made regarding the necessary Comcast and ComEd utility relocations. At that time, it was noted that a future change order may be necessary to address a time extension for DiMeo Brothers, Inc. related to the utility relocation delays. The utility relocation work took much longer than anticipated and as such delayed DiMeo's start date for the project with mobilization for construction taking place on September 10, 2018.
