**Item Title: Surplus Property Disposal Ordinance**

**VILLAGE BOARD ACTION**

**Pass an ordinance to declare surplus certain personal property of the Village of Roselle.**

**Executive Summary:**

The fire department has replaced certain equipment that has been determined to be at the end of its useful life or is no longer useful to the Village and request for the items to be declared surplus.

- 40 – Sections of Fire Hose – Various Lengths and Sizes
- 2 – Ferno Manual Ambulance Cots
- 1 – Fire Safety House

The surplus hose is a result of the of the standardizing of our hose to be consistent the West Suburban Fire Rescue Alliance. The Ferno ambulance cots were replaced when the ambulances were upgraded with the power load cots several years ago. The hose and cots will be given to the Romeoville Fire Academy in exchange for them waiving tuition for several of our personnel enrolled in classes.

The Fire Safety House is in excess of 10 years old and is experiencing several maintenance issues. The safety house is only used once a year and has not been used for the past 18 months due to COVID-19. The fire safety house will be donated to another fire department or listed on the auction site if no fire department wants it.

**ORDINANCE NO. 2021-**

**AN ORDINANCE TO DECLARE SURPLUS CERTAIN PERSONAL PROPERTY  
OF THE VILLAGE OF ROSELLE, ILLINOIS**

WHEREAS, it has been determined by the Mayor and Board of Trustees of the Village of Roselle that certain personal property of the Village is no longer needed and/or operational and is surplus; and

WHEREAS, it is in the best interests of the Village to sell or dispose of this personal property; and

WHEREAS, the Village has exhausted the useful life of certain equipment rendering them obsolete for any future use for the Village;

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Board of Trustees of the Village of Roselle, DuPage and Cook Counties, Illinois, as follows:

SECTION 1: That the Village Administrator is hereby authorized and directed to donate, trade-in, sell and otherwise dispose of/recycle the following personal property now owned by the Village of Roselle.

- 40 – Sections of Fire Hose – Various Lengths and Sizes
- 2 – Ferno Manual Ambulance Cots
- 1 – Fire Safety House

SECTION 2: This Ordinance shall be in full force and effect from and after its passage, by a vote of at least three-fourths of the corporate authorities and approval in the manner provided by law.
