**EXECUTIVE ORDER OF THE MAYOR OF THE VILLAGE OF ROSELLE,
ILLINOIS: “TO DECLARE SURPLUS CERTAIN PERSONAL PROPERTY AND
EXECUTE AN AGREEMENT BETWEEN DALMATION FIRE EQUIPEMNT,
INC. AND VILLAGE OF ROSELLE”**

WHEREAS, Article XIX “Emergency and Disasters” of Chapter 2 “Administration” of the Roselle Village Code grants authorization to the Mayor of the Village of Roselle to enter executive orders “upon the declaration of a local state of emergency”; and

WHEREAS, the authority to declare a state of emergency and to issue local executive orders under Chapter 2 Article XIX is exclusive to the Mayor; and

WHEREAS, on March 20, 2020, I the Mayor of the Village of Roselle, Andrew Maglio, entered a declaration of local state of emergency based on the COVID-19 pandemic, which was approved and extended by the Village Board until May 11, 2020; and

WHEREAS, on January 27, 2020 the Village Board approved a contract for the purchase of 20 Self Contained Breathing Apparatus (SCBA) from Municipal Emergency Services to replace the existing SBCEA’s that were non-compliant with recent NFPA standards; and

WHEREAS, the Fire Department currently has 42 SCBA that are obsolete and no longer needed due to age, condition, and non-compliance with NFPA standards; and

WHEREAS, Dalmatian Fire Equipment, Inc. has agreed to exchange the 42 units of SCBA for 12 SCBA’s that are deemed useful and needed for the Fire Department as they are compatible with the recently purchased 20 SCBA and will be used by the Fire Department for training and Fire Department related activities; and

WHEREAS, in absence of the exchange the 42 SCBA units would be surplus property with no economic value; and

WHEREAS, a prompt exchange is essential to maximize the benefits of the exchange for the Village; and

WHEREAS, the Village of Roselle must take actions to provide essential and critical services for the health and safety of the community and it is the best interests of the Village to exchange the 42 units of SCBA with Dalmatian Fire Equipment, Inc.

NOW, THEREFORE, BASED ON THE FOREGOING RECITALS, I, Andrew Maglio, as Mayor of the Village of Roselle, hereby order instanter, pursuant to my executive powers granted by law and the declaration of emergency the following:

SECTION 1: Declare Surplus Certain Personal Property: I hereby declare the 42 units of SCBA as obsolete and surplus to the needs and uses of the Village of Roselle.

SECTION 2: Agreement with Dalmatian Fire Equipment: Furthermore, I authorize the Village Administrator to enter into an agreement with Dalmatian Fire Equipment, Inc. to exchange the Village's 42 surplus property for 12 SCBA's, which will be used for training and Fire Department related activities.
