**Item Title:**           **Amendment to Roselle Liquor Ordinance – Increase Class I and Class F**

**VILLAGE BOARD ACTION**

**Pass an ordinance amending the “Code of Ordinances, Village of Roselle, Illinois” limitation on number of licenses covering the sale of alcoholic liquors in the Village of Roselle to increase the number class “I” licenses from 7 to 8, and the number of class “F” licenses from 11 to 12.**

**Executive Summary:**

Every new liquor license must be accounted for in the Liquor Code. Currently, for the class I, there are 7 licenses available. A new license for Southern Café will increase this to 8 licenses. Currently for class F, we have 11 licenses available. The addition of Rookies has increased this to 12 licenses. Both licenses have been approved by the Liquor Commissioner.

**ORDINANCE NO. 2019-**

**AN ORDINANCE AMENDING THE  
“CODE OF ORDINANCES, VILLAGE OF ROSELLE, ILLINOIS” LIMITATION ON  
NUMBER OF LICENSES COVERING THE SALE OF ALCOHOLIC LIQUORS IN THE  
VILLAGE OF ROSELLE TO INCREASE THE NUMBER OF CLASS “I” LICENSES  
FROM 7 TO 8, AND THE NUMBER OF CLASS “F” LICENSSES FROM 11 TO 12.**

BE IT ORDAINED BY the Mayor and Board of Trustees of the Village of  
Roselle, DuPage and Cook Counties, Illinois, as follows:

SECTION 1: That the “Code of Ordinances, Village of Roselle, Illinois,” Chapter 3  
entitled, “Alcoholic Beverages, Section 3-33, Limitation on number of Licenses” shall be  
amended as follows:

**Increase the number of Class “F” Licenses from 11 to 12**  
Rookies-5 American Bar & Grill      1360 Lake Street  
**Increase the number of Class “I” Licenses from 7 to 8**  
Southern Cafe                              511 N. Roselle Rd. Roselle

SECTION 2: That all parts of ordinances in conflict herewith are hereby repealed to  
the extent of such inconsistency.

SECTION 3: Should any court of competent jurisdiction find any portion of this  
Ordinance to be legally invalid; such partial invalidity shall not affect the remainder of the  
Ordinance.

SECTION 4: That this Ordinance shall be in full force and effect upon its passage  
and publication in pamphlet form.
