**Item Title:**           **Motor Fuel Tax (MFT) Resolution**

**VILLAGE BOARD ACTION**

**Adopt an Illinois Department of Transportation (IDOT) Resolution authorizing expenditures totaling \$1,500,000 of Motor Fuel Tax Funds in 2021 for the maintenance and improvement of streets and right-of-ways under the Illinois Highway Code.**

**Executive Summary:**

The attached *Resolution for Maintenance of Streets and Highways by Municipality Under the Illinois Highway Code* is required in order to authorize the expenditure of Motor Fuel Tax (MFT) funds. The Village is estimating that \$1,500,000 of MFT funds will be expended on street and right-of-way improvement and maintenance programs in 2021.

**Implications:**

**Is this item budgeted?**   Yes, the \$1,500,000 includes a transfer of \$300,000 to the General Fund for street maintenance projects/operations and \$1,200,000 for the Street Improvement Program (SIP) included in the FY 2021 MFT Budget.

Resolution for Maintenance Under the Illinois Highway Code

BE IT RESOLVED, by the President and Board of Trustees of the Village of Roselle Illinois that there is hereby appropriated the sum of One Million and 00/100 Dollars (\$1,500,000.00)

of Motor Fuel Tax funds for the purpose of maintaining streets and highways under the applicable provisions of Illinois Highway Code from 01/01/21 to 12/31/21

BE IT FURTHER RESOLVED, that only those operations as listed and described on the approved Estimate of Maintenance Costs, including supplemental or revised estimates approved in connection with this resolution, are eligible for maintenance with Motor Fuel Tax funds during the period as specified above.

BE IT FURTHER RESOLVED, that Village of Roselle shall submit within three months after the end of the maintenance period as stated above, to the Department of Transportation, on forms available from the Department, a certified statement showing expenditures and the balances remaining in the funds authorized for expenditure by the Department under this appropriation, and

BE IT FURTHER RESOLVED, that the Clerk is hereby directed to transmit four (4) certified originals of this resolution to the district office of the Department of Transportation.
