Item Title: Parking Regulations for Town Center Parking

VILLAGE BOARD ACTION

Pass an ordinance which repeals, amends and adds parking regulations to the Town Center area.

Executive Summary:

At the August 23 Village Board meeting, staff provided an overview of existing parking regulations in the Town Center area. Staff made seven recommendations to make changes or modifications to the ordinances based on this review and to comply with the Manual on Uniform Traffic Control Devices (MUTCD). These changes are for Prospect Street, Park Street, Maple Avenue, Howard Street and Elm Street.

Implications:

Is this item budgeted? Yes, these parking updates are budgeted within the Public Works Budget.

Any other implications to be considered? Per the Board's previous direction, letters were mailed to residences impacted by the changes.

ORDINANCE NO. _____

**AN ORDINANCE AMENDING CHAPTER 10,
OF THE CODE OF ORDINANCES**

WHEREAS the Corporate Authorities of the Village of Roselle deem that regulating parking of vehicles on Village Streets increases the safety and welfare of the citizens of Roselle, and unregulated parking in defined areas is detrimental to the welfare of the inhabitants of the Village of Roselle.

SECTION 1: NOW THEREFORE, BE IT ORDAINED by the Corporate Authorities of the Village of Roselle, DuPage and Cook Counties, Illinois, that the following sub sections of Section 3, Appendix V, Chapter 10 of the Village code are hereby repealed and rescinded:

That the line **“Prospect Street – East side from Elm Street and for 200 feet north of Elm Street shall be a 30-minute parking limitation only on Monday through Friday from 8:00 a.m. to 4:00 p.m..”** in Section 3 of Appendix V, Chapter 10 of the Roselle Village Code; is hereby repealed in it’s entirety; and

That the line **“Park Street – East side between Maple Avenue on the south and the north driveway of the library parking lot on the north, four-hour parking between the hours of 6:00 a.m. and 6:00 p.m..”** in Section 3, of Appendix V, Chapter 10 of the Roselle Village Code; “No parking at designated times; is hereby repealed and rescinded in its entirety; and

That the line: **“Maple Avenue North side from the east line of Spring Street to a point 192 feet east there shall be no parking from 6:00 a.m. to 8:00 a.m. and from 4:00 p.m. to 6:00 p.m. Monday through Friday, except those displaying a valid, individually coded parking cars as provided for in chapter 18, article VI of the Code of Ordinances of the Village of Roselle.** Chapter 10, in Section 3 Appendix V of Chapter 10 of the Roselle Village Code is hereby repealed and rescinded in its entirety; and

That the lines, “Two-hour parking between 6:00 a.m. and 6:00 p.m. weekdays is hereby repealed and rescinded the line entitled, **Howard Street West side of Howard Street from the intersection of Main Street to the intersection of Elm Street.**” in Section 4A of Appendix V, Chapter 10, is hereby repealed and rescinded the line entirety

Section 2: BE FURTHER BE IT ORDAINED by the Corporate Authorities of the Village of Roselle, DuPage and Cook Counties, Illinois that the following sections of the Roselle Village Code are hereby amended as follows:

That the line “Elm Street – North side between prospect Street and 4th street” ,of Section 1, Appendix V of Chapter 10; “No parking at any time”, of the Roselle Village Code : is hereby repealed and rescinded and replaced with a new line in Section 1 of Appendix V Chapter 10 No Parking at Any Time” which shall read: ” **Elm Street – North side of Elm Street from the intersection of Roselle Road to the intersection of Prospect Street.**” And

That the line “Prospect Street – West side between Main Street on the north and Elm Avenue on the south”, of Section 1, Appendix V, Chapter 10;” No parking at any time” of the Roselle Village Code is hereby repealed and rescinded and replaced with a new line in Section 1 of Appendix V, Chapter 10, No Parking at Any Time” which shall read“ **Prospect Street – West side from the intersection of Main Street to the Intersection of Maple Avenue**”.

Section 3: FURTHER BE IT ORDAINED by the Corporate Authorities of the Village of Roselle, DuPage and Cook Counties, Illinois that the following section of the Roselle Village Code “No Parking at Any Time” is hereby amended to include a new line in Section 1, Appendix V, Chapter 10:

Chapter 10, Appendix V, Section 1; “No Parking at Any Time”, of the Code of Ordinances which will now include a new line to be inserted alphabetically which shall read: **Howard Street – East side of Howard Street from the Intersection of Elm Street to the intersection of Main Street.**

SECTION 4: That in all other respects Chapter 10, Sections 1, 3 and 4A, and their Appendixes OF THE Code of Ordinances are hereby reaffirmed.

SECTION 5: THAT if any part, portion or section of this Ordinance is for any reason held invalid, such decision shall not affect the validity of any other portion of the “Code of Ordinances of the Village of Roselle”.

SECTION 6: THAT all parts of ordinances in conflict herewith are hereby repealed to the extent of such conflict.

SECTION 7: THAT this amending ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as is hereby authorized to be done by the Mayor and Board of Trustees.
