Item Title: **Saturday Work Hours**

VILLAGE BOARD ACTION

Pass an ordinance authorizing Gerardi Sewer and Water Co. approval to perform work on the 2022 Watermain Replacement Program on Saturdays.

Executive Summary:

Village Code (Section 11-2) prohibits Saturday work without prior authorization by the Village Board unless it is an emergency.

Gerardi Sewer and Water Co. is currently under contract with the Village for the 2022 Watermain Replacement Program. The construction of the project is underway. In accordance with the existing Village Code, as a proactive measure, Gerardi is requesting approval to work on Saturdays as needed should they encounter inclement weather, unforeseen site conditions or to accommodate coordination with deliveries and subcontractors' work. Saturday work hours have been approved by the Village Board in the past for Village contractors based upon the following conditions:

- Specific Saturday requests must be in writing and received by the Village no later than 8:00 AM on the Thursday prior to the proposed Saturday work, i.e. 48 hours in advance.
- All requests shall be reviewed and approved by the Public Works Director.
- Work hours are limited to 8:00 AM to 4:00 PM
- Construction activities that create a large amount of dust or noise shall be minimized.

Gerardi does not have any specific weekends they are requesting work at this time. This approval would allow Saturday work, but only by meeting the conditions stated above, should a request be made. Staff has no objections to this request.

RESOLUTION NO. 2022-

AN ORDINANCE AUTHORIZING GERARDI SEWER AND WATER CO. APPROVAL TO PERFORM WORK ON THE 2022 WATERMAIN REPLACEMENT PROGRAM ON SATURDAYS

WHEREAS, Gerardi Sewer and Water Co. is the contractor awarded the work on the 2022 Watermain Replacement Program; and

WHEREAS, Gerardi Sewer and Water Co. has requested approval to work on Saturdays; and

WHEREAS, the work associated with the project is weather dependent and the project is has a short timeframe for completion and working on Saturdays would help ensure the on time completion of the project, thereby reducing inconvenience to residents in the immediate area; and

WHEREAS, Chapter 11.2 (10) of the Village's Municipal Code prohibits construction on a public or private improvement outside of 7:00 am to 6:00 pm Monday through Friday; and

WHEREAS, the Village's Municipal Code permits the Village Board to extend these hours upon formal application by the party of interest.

NOW, THEREFORE, be it ordained by the Mayor and Board of Trustees of the Village of Roselle that the Mayor and Village Board hereby authorize Gerardi Sewer and Water Co. to work on Saturdays in accordance with the following:

1. This extension limits construction to occur between the hours of 8:00 am until 4:00 pm on Saturdays.
2. Specific Saturday requests must be in writing and received by the Village no later than 8:00 AM on the Thursday prior to the proposed Saturday work, i.e. 48 hours in advance.
3. All requests shall be reviewed and approved by the Public Works Director.
4. Construction activities that create a large amount of dust or noise shall be minimized.
5. Any modification of these permitted Saturday hours will require further Village Board approval.
6. The Mayor and the Board of Trustees shall maintain the ability to reinstate original works hours and all other terms of the existing contract between Gerardi Sewer and Water Co. and the Village of Roselle should they deem it in the best interests of the Village.
