**Item Title: Purchase of Public Works Vehicle**

**VILLAGE BOARD ACTION**

**Adopt a resolution authorizing the purchase of a 2022 Ford Escape from Friendly Ford of Roselle in the amount of \$31,190.39.**

**Executive Summary:**

The Village has been notified that six of the vehicles we ordered through Ford in 2021 have been cancelled. The ongoing computer chip shortage has impacted the ability to locate and acquire vehicles at a competitive price. Vehicle prices are at a premium and our ability to purchase vehicles through government or fleet pricing has not been available. Staff was able to locate a 2022 Ford Escape at the local Friendly Ford dealership. This vehicle will be assigned to the Public Works Department to replace the vehicle that was transferred to the Community Development Department for the Code Compliance/Building Inspector.

The previously ordered Ford Escape was a hybrid in the amount of \$27,355 and was cancelled by Ford earlier this year. The order date for hybrids is not anticipated again until late 2022, with no understanding of the pricing structure or guarantee that the order will be fulfilled. Staff recommends the purchase of the 2022 Ford Escape from Friendly Ford of Roselle at a cost not to exceed \$31,190.39.

Section 2: Village staff are authorized and directed to undertake any and all other tasks necessary, or in furtherance of, to purchase the 2022 Ford vehicle.
