**AN ORDINANCE  
ABATING THE PROPERTY TAX LEVIED FOR  
THE YEAR 2022 TO PAY THE PRINCIPAL AND INTEREST ON  
\$1,420,000.00 GENERAL OBLIGATION BONDS  
(ALTERNATE REVENUE SOURCE), SERIES 2012B, OF  
THE VILLAGE OF ROSELLE,  
DUPAGE AND COOK COUNTIES, ILLINOIS**

**WHEREAS**, the Village of Roselle is a municipal corporation organized pursuant to the laws of the State of Illinois possessing certain powers and perform certain functions pertaining to its local government and affairs as provided for by and through the Illinois Municipal Code and Illinois Statute;

**WHEREAS**, the Mayor and Board of Trustees (hereinafter referred to as the "Board") of the Village of Roselle, DuPage and Cook Counties, Illinois (hereinafter referred to as the "Village"), by Ordinance Number 2012-3621, adopted on the 26th day of March, 2012 (hereinafter referred to as the "Ordinance"), which provided for the issuance of \$1,500,000.00 General Obligation Bonds (Alternate Revenue Source), Series 2012B (hereinafter referred to as the "Bonds"), and the levy of a direct annual tax sufficient to pay the principal of and interest on the Bonds;

**WHEREAS**, the prior Ordinance is in full force and effect, and has been filed in the Office of the County Clerks in DuPage and Cook Counties, respectively;

**WHEREAS**, the Village Treasurer has determined that funds are available to pay the principal and interest when due and payable, specifically, that pledged revenues are available in an amount not less than 1.00 times debt service of all outstanding bonds in the next succeeding bond year;

**WHEREAS**, the aforementioned revenues have been deposited in the Village of Roselle 2012B Bond Fund in an amount sufficient to pay debt service on all outstanding bonds in the next succeeding bond year when they become due and payable;

**WHEREAS**, the Corporate Authorities are of the opinion that it is necessary and in the best interests of the Village that the tax heretofore levied for the upcoming tax year to pay the principal of and interest on the Bonds be abated; and

**WHEREAS**, the Corporate Authorities hereby finds and determines that it is advisable and necessary to provide for abatement of the tax heretofore levied for the year 2022.

**NOW, THEREFORE, BE IT ORDAINED**, in open meeting assembled, by the Village President and Board of Trustees of the Village of Roselle, DuPage and Cook Counties, Illinois, as follows:

**Section One – Recitals**

The Corporate Authorities hereby find that all of the recitals hereinbefore stated as contained in the preamble to the ordinance are full, true and correct and do hereby, by reference, incorporate and make them part of this ordinance as legislative findings.

**Section Two – Abatement of Tax**

- a) The tax heretofore levied for the year 2022 in Ordinance Number 2012-3621 is hereby abated in its entirety.
- b) This ordinance shall constitute authority for the DuPage and Cook County Clerks for levy years set forth herein to abate the levy as set forth herein.

**Section Three – Direction**

The Mayor and Board of Trustees of the Village of Roselle direct the Village Clerk to immediately file a certified copy of this ordinance with the DuPage and Cook County Clerk's Offices, respectively.

**Section Four – Effective Date**

This ordinance shall be in full force and effect from and after its passage, approval and publication as provided by law.

**Section Five - Publication**

This ordinance shall be published in book or pamphlet form as provided by the Illinois Municipal Code.

**Section Six – Conflict Clause**

All ordinances, parts of ordinances, resolutions, parts of resolutions or board actions in conflict herewith are hereby repealed to the extent of such conflict.

**Section Seven – Saving Clause**

If any section, paragraph, clause or provision of this ordinance is declared by a court of law to be invalid or unconstitutional, the invalidity or unconstitutionality thereof shall not affect the validity of any other provisions of this ordinance, which are hereby declared to be separable.

**Section Eight – Recording**

This ordinance shall be entered into the minutes and upon the journals of the Board of Trustees of the Village of Roselle.
